Welcome to the Britton Price Sling Selector ("App"). This Privacy Policy explains how we handle information in our App. We are committed to protecting your privacy and ensuring you have a positive experience using our App.

**2.0. INFORMATION WE DO NOT COLLECT**

2.1 No Personal Information Collection - Our App is designed as a standalone tool that operates entirely on your device. We **DO NOT** collect, store, or transmit:

- Personal identification information (name, email, phone number)
- Medical records or health information
- User account information
- Location data
- Contact lists or address books
- Payment information
- Device identifiers (UDID, IMEI, MAC address)

2.2 Local Data Only - All data you enter into the App (measurements, selections, preferences) remains exclusively on your device. We have no access to this information.

**3.0 INFORMATION PROCESSED LOCALLY**

3.1 Measurement Data - The App processes the following types of data locally on your device:

- Body measurements entered for sling sizing (in centimeters)
- Sling type selections
- Calculation results and size recommendations
- User preferences and settings

3.2 How We Use This Data (Locally) - The data you enter is used solely for:

- Calculating appropriate sling sizes based on your measurements
- Displaying relevant product information and recommendations

- Improving your user experience within the App
- Maintaining your preferences between app sessions (locally)

#### **4.0 DATA STORAGE AND SECURITY**

4.1 Local Storage - All data is stored locally on your device using:

- Device storage (caching)
- Local database (for measurement history if enabled)

4.2 Data Retention

- Your measurement data persists only as long as you keep the App installed
- You can clear all data by uninstalling the App
- Individual measurement sessions can be deleted within the App

4.3 Security Measures

- All data remains on your device
- No internet transmission of your data
- No cloud storage or backup of your data
- No sharing with third parties

#### **5.0 THIRD-PARTY SERVICES**

5.1 No Third-Party Data Sharing - We do not share any data with third parties since we do not collect any data from you.

5.2 App Store Privacy - Our App is distributed through official app stores (Google Play Store, Apple App Store) which may collect standard installation data as per their privacy policies.

6.1 Our App is suitable for all ages as it does not:

- Collect personal information
- Require user registration
- Display inappropriate content
- Share data with third parties

However, we recommend parental supervision for children using measurement tools.
